LIABILITY WAIVER Waiver of Liability, Assumption of Risk, and Indemnity Agreement

<u>Waiver of Liability</u>: In consideration of being permitted to participate as a volunteer for the Urbana Park District, I, for myself, my heirs, personal representatives or assigns, **do hereby release, waive, discharge, and covenant not to sue** the Urbana Park District, its officers, employees, agents and assigns from liability for any and all claims, including those which result in personal injury, accidents, or illnesses (including death), and property loss arising from, but not limited to, participation as a volunteer for the Urbana Park District.

<u>Assumption of Risks</u>: I acknowledge that participation as a volunteer carries certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. I acknowledge that the specific risks vary from one activity to another, and include but are not limited to minor injuries such as scratches, bruises, cuts and sprains and major injuries such as eye injury, loss of sight, joint or back injuries and broken bones and that any activities in the water include the possibility of drowning.

I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in participation. I hereby assert that my participation is voluntary and that I knowingly assume all risks.

Indemnification and Hold Harmless: I also agree to INDEMNIFY AND HOLD HARMLESS the Urbana Park District from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees, brought as a result of my involvement as a volunteer and to reimburse it for any such expenses incurred.

<u>Acknowledgement of Understanding</u>: I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and **understand that I am giving up substantial rights, including my right to sue**. I acknowledge that I am signing the agreement freely and voluntarily, and **intend by my signature for this form to be a complete and unconditional release of all liability** to the greatest extent allowed by law.
